STRATEGY: PROVIDE A COMPREHENSIVE CORE CURRICULUM INTEGRATING WEB-BASED LEARNING AND CURRENT TECHNOLOGIES WHILE CONTINUOUSLY EVALUATING STUDENT ACHIEVEMENT.
